Property Type	Definitions

Multi-Unit (2-6 units) #of Units	If the property contains 2 to 6 self-contained residential dwelling units, it is considered to be a residential Multi-Unit Dwelling.
Condominium	Individual ownership of a unit in a multi unit building or townhouse complex, where monthly fees are paid to a Condominium Corporation, but does not include Co-operatives units.
Waterfront	Land with buildings or a section of a town fronting or touching a body of water.
